

Lowering Health Care Costs for Families

The President knows that too many Americans stare at the ceiling wondering what happens if their spouse gets cancer or child gets sick. He believes that every American has a right to the peace of mind that comes with knowing they have access to affordable, quality health care. President Biden passed legislation to lower health care and prescription drug costs for American families, giving families more breathing room. Tomorrow, he will discuss the historic progress we have made on lowering health care costs under his watch, including steps

to strengthen Medicare, Medicaid, and the Affordable Care Act (ACA), and steps we must take to build on that progress and give more families the peace of mind of affordable prescriptions and health care.

\$800 lower health care premiums. A record-setting <u>16.3 million people</u> signed up for ACA coverage this year, and the national uninsured rate hit an <u>all-time low</u> last year. That's thanks in large part to President Biden and Democrats in Congress' work to lower premiums for ACA coverage by an average of \$800 per person per year—along with President Biden's actions to <u>quadruple</u> consumer assistance, increase outreach, and close the "<u>family glitch</u>" loophole that blocked many children and spouses from affordable coverage. Tomorrow, the President will call on Congress to make these savings for American families permanent, so we can continue our work to make health care a right, not a privilege.

60 million Medicare beneficiaries will be protected from skyrocketing drug costs. President Biden took on Big Pharma—and won. <u>Thanks to the new prescription drug law</u>, Medicare will be able to negotiate drug prices and cap out-of-pocket pharmacy costs at \$2,000 per year under Part D, and drug companies will pay rebates to Medicare if they try to hike their prices faster than the rate of inflation. For the last six weeks, seniors across the country have been benefiting from key drug pricing protections that are putting money back in their pockets:

- \$35 price cap on insulin in Medicare. Starting this year, Medicare beneficiaries will pay no more than \$35 per month per insulin prescription. 1.5 million people would have each saved, on average, <u>\$500 per year</u> had this law been in effect in 2020. The President will call on Congress to extend this commonsense, life-saving protection to all Americans, not just people with Medicare.
- \$0 vaccines through Medicare. More adult vaccines are <u>now available</u> without any co-pays under Medicare Part D thanks to the new prescription drug law. This includes the shingles vaccine, which used to cost seniors as much as \$200.

1 million surprise medical bills are prevented every month. Before President Biden took office, millions of people received surprise bills for out-of-network care, costing them hundreds or thousands of dollars. The Administration is <u>protecting</u> millions of consumers from surprise medical bills through the <u>implementation</u> of the No Surprises Act, which has already protected 10 million Americans from unfair, undeserved out-of-network charges.

\$3,000 in savings on hearing aids. In October 2022, over-the-counter hearing aids hit the shelves following a <u>rule</u> from the Food and Drug Administration. Now, millions of Americans can buy hearing aids for low to moderate hearing loss without a prescription or exam. This is anticipated to <u>save</u> Americans as much as \$3,000

per pair, providing more breathing room for the estimated 30 million Americans with mild-to-moderate hearing loss.

39 states and the District of Columbia have expanded Medicaid coverage. Missouri, Oklahoma, and South Dakota are the most recent states to expand Medicaid to hundreds of thousands of low-income adults previously locked out of Medicaid coverage. The Administration remains committed to closing the coverage gap in the remaining 11 states, and the President will call on Congress to finish the job. In addition, the Administration also worked with over half the states and DC to extend Medicaid postpartum coverage for millions of women.

Promoting Competition

Improving safety and accountability in nursing homes. As the President directed in last year's State of the Union, CMS has taken action to <u>strengthen oversight</u> of the worst performing nursing homes, <u>prevent</u> abuse and Medicare fraud, and <u>improve</u> families' ability to comparison shop across nursing homes. In the coming days and months, CMS will announce new actions to increase safety and accountability at nursing homes.



Tomorrow, he will discuss the historic progress we have made on lowering health care costs under his watch, including steps to strengthen Medicare, Medicaid, and the Affordable Care Act (ACA), and steps we must take to build on that progress and give more families the peace of mind of affordable prescriptions and health care.

\$800 lower health care premiums. A record-setting <u>16.3 million people</u> signed up for ACA coverage this year, and the national uninsured rate hit an <u>all-time low</u> last year. That's thanks in large part to President Biden and Democrats in Congress' work to lower premiums for ACA coverage by an average of \$800 per person per year—along with President Biden's actions to <u>quadruple</u> consumer assistance, increase outreach, and close the "<u>family glitch</u>" loophole that blocked many children and spouses from affordable coverage. Tomorrow, the President will call on Congress to make these savings for American families permanent, so we can continue our work to make health care a right, not a privilege.

60 million Medicare beneficiaries will be protected from skyrocketing drug costs. President Biden took on Big Pharma—and won. <u>Thanks to the new prescription drug law</u>, Medicare will be able to negotiate drug prices and cap out-of-pocket pharmacy costs at \$2,000 per year under Part D, and drug companies will pay rebates to Medicare if they try to hike their prices faster than the rate of inflation. For the last six weeks, seniors across the country have been benefiting from key drug pricing protections that are putting money back in their pockets:

- \$35 price cap on insulin in Medicare. Starting this year, Medicare beneficiaries will pay no more than \$35 per month per insulin prescription. 1.5 million people would have each saved, on average, <u>\$500 per year</u> had this law been in effect in 2020. The President will call on Congress to extend this commonsense, life-saving protection to all Americans, not just people with Medicare.
- \$0 vaccines through Medicare. More adult vaccines are <u>now available</u> without any co-pays under Medicare Part D thanks to the new prescription drug law. This includes the shingles vaccine, which used to cost seniors as much as \$200.

1 million surprise medical bills are prevented every month. Before President Biden took office, millions of people received surprise bills for out-of-network care, costing them hundreds or thousands of dollars. The Administration is protecting millions of consumers from surprise medical bills through the <u>implementation</u> of

the No Surprises Act, which has already protected 10 million Americans from unfair, undeserved out-ofnetwork charges.

\$3,000 in savings on hearing aids. In October 2022, over-the-counter hearing aids hit the shelves following a <u>rule</u> from the Food and Drug Administration. Now, millions of Americans can buy hearing aids for low to moderate hearing loss without a prescription or exam. This is anticipated to <u>save</u> Americans as much as \$3,000 per pair, providing more breathing room for the estimated 30 million Americans with mild-to-moderate hearing loss.

39 states and the District of Columbia have expanded Medicaid coverage. Missouri, Oklahoma, and South Dakota are the most recent states to expand Medicaid to hundreds of thousands of low-income adults previously locked out of Medicaid coverage. The Administration remains committed to closing the coverage gap in the remaining 11 states, and the President will call on Congress to finish the job. In addition, the Administration also worked with over half the states and DC to extend Medicaid postpartum coverage for millions of women.

Promoting Competition

Improving safety and accountability in nursing homes. As the President directed in last year's State of the Union, CMS has taken action to <u>strengthen oversight</u> of the worst performing nursing homes, <u>prevent</u> abuse and Medicare fraud, and <u>improve</u> families' ability to comparison shop across nursing homes. In the coming days and months, CMS will announce new actions to increase safety and accountability at nursing homes.

Plans are moving forward at the US Department of Health and Human Services to prepare for the end of the nation's Covid-19 public health emergency declaration in May. On Thursday, HHS Secretary Xavier Becerra sent a letter and fact sheet to state governors detailing what exactly the end of the emergency declaration will mean for jurisdictions and their residents. "Addressing COVID-19 remains a significant public health priority for the Administration, and over the next few months, we will transition our COVID-19 policies, as well as the current flexibilities enabled by the COVID-19 emergency declarations, into improving standards of care for patients. We will work closely with partners including state, local, Tribal, and territorial agencies, industry, and advocates, to ensure an orderly transition," Becerra wrote in a draft of the letter obtained by CNN.

KEY POINTS

- Health Secretary Xavier Becerra officially informed the state governors on Thursday that he is renewing the Covid public health emergency a final time but will let it expire on May 11.

The Health and Human Services Department on Thursday laid out what will change and will remain the same when the three-year-long Covid public health emergency ends in May. Health Secretary Xavier Becerra officially informed the state governors on Thursday that he is renewing the declaration a final time but plans to let the emergency expire on May 11. The White House had already informed Congress of these plans last week. HHS officials in call with reporters laid out what the the public can expect when the emergency ends.

Immediate changes:

- People with private health insurance may have to pay for Covid tests, both over-the-counter and lab, depending on their plan.
- Seniors with Medicare Part B will start paying for over-the-counter tests, though the program will cover lab tests.
- Hospitals will lose flexibility to expand capacity in response to surges.
- The federal government can no longer require labs to report Covid test results to the Centers for Disease Control and
 Preve

Longer-term changes

- Covid vaccines and antivirals such as Paxlovid will remain free to everyone regardless of insurance status until the current federal stockpile runs out.
- Expanded telehealth through Medicare will also remain in place through December 2024 under federal spending legislation passed in December. But it will end after that without congressional intervention.

The Food and Drug Administration will still have the authority to rapidly authorize Covid vaccines, tests and treatments through its separate emergency powers.

Millions of people are also at risk of losing health insurance through Medicaid this year as federal protections that kept people covered during the pandemic come to an end. These protections were once tied to the public health emergency, but Congress then decided to phase them out separately.

In short, states can start kicking people off Medicaid as early as April if they no longer meet eligibility requirements for the public health insurance program. HHS plans to open a special enrollment period so these individuals can apply for coverage through the Affordable Care Act.

Although Covid vaccines and treatments will remain free for everyone after the public health emergency ends, this may change for uninsured adults when the federal stockpile runs out.

The Biden administration plans to stop buying vaccines and treatments for the public as early as this fall in part because Congress has not appropriated additional funding. When the federal government pulls out, vaccines and treatments will be purchased and distributed through the private market.

This means Pfizer and Moderna will sell the shots directly to health-care providers and whether you pay will depend on whether you are insured.

People with insurance through the Affordable Care Act and Medicare will still get the shots for for free. Those on Medicaid will get the shots for free through September 2024, after which coverage will vary from state to state.

Adults who are uninsured will likely have to pay for the shots when the stockpile runs out, though the White House has said it's developing plans to help them.

US News & World Report: <u>Biden Administration Releases COVID-19 Public Health Emergency Transition Road Map</u> Cecelia Smith-Schoenwalder

The Biden administration gave formal notice to governors that it is lifting its public health emergency declaration in May – a move with sweeping implications for health care and immigration. The Biden administration on Thursday formally alerted governors that the COVID-19 public health emergency declaration will end in May and released a "road map" for the transition out of the emergency phase.

"Addressing COVID-19 remains a significant public health priority for the Administration, and over the next few months, we will transition our COVID-19 policies, as well as the current flexibilities enabled by the COVID-19 emergency declarations, into improving standards of care for patients," Health and Human Services Secretary Xavier Becerra wrote in a letter to governors dated Thursday. "We will work closely with partners including state, local, Tribal, and territorial agencies, industry, and advocates, to ensure an orderly transition."

Access to vaccines and treatments like Paxlovid will generally not be affected when the public health emergencies end, HHS officials said on a call with reporters on Thursday. But certain things will change, including potentially the cost of COVID-19 testing for the insured. The administration said that "coverage may continue if plans choose to continue to include it."

Additionally, HHS will no longer be able to require certain COVID-19 testing data from labs, which could "affect the reporting of negative test results and impact the ability to calculate percent positivity for COVID-19 tests in some jurisdictions," according to a fact sheet about the road map.

Certain Medicare and Medicaid waivers for health care providers will also end come mid-May.

The administration said that the Centers for Medicare and Medicaid Services will provide information in the coming days "about the waivers many states and health systems have adopted and how they will be impacted by the end of the COVID-19 PHE."

The Biden administration's plan to end the COVID-19 public health emergencies in May is sure to send ripples through several government operations, including health care and immigration.

The announcement about the lifting of the COVID-19 emergencies came the same day the World Health Organization decided that the pandemic remains a public health emergency of international concern. The decision was widely expected given the latest COVID-19 surge in China, which experts believe to be drastically undercounted. Still, the organization said that COVID-19 is likely at a "transition point."

President Joe Biden during his State of the Union address this week said that COVID-19 "no longer controls our lives."

"While the virus is not gone, thanks to the resilience of the American people and the ingenuity of medicine, we've broken the COVID grip on us," he said. "COVID deaths are down by 90%. We've saved millions of lives and we opened our country back up. And soon, we'll end the public health emergency."

The Biden administration has released its roadmap for transitioning out of the three-year-old U.S. pandemic public health emergency, while the House of Representatives voted to end the requirement for foreign visitors to the U.S. to show proof of vaccination. China says its COVID cases have plunged 98% from their peak and a study finds that the surge

there was not caused by new variants. But the politicization of the pandemic remains a disheartening reality, as a new study finds conservative doctors less likely to support vaccination.

White House releases public health emergency transition fact sheet

The Department of Health and Human Services on Thursday released its anticipated COVID-19 public health emergency transition roadmap, outlining the changes Americans can expect after May 11. The agency said that compared to last January, daily reported cases are down 92%, deaths have declined by over 80%, and hospitalizations are down nearly 80%.

"We have come to this point in our fight against the virus because of our historic investments and our efforts to mitigate its worst impacts," the document said. "Addressing COVID-19 remains a significant public health priority for the administration, and over the next few months, we will transition our COVID-19 policies, as well as the current flexibilities enabled by the COVID-19 emergency declarations, into improving standards of care for patients."

The HHS said that access to COVID-19 vaccinations and treatments such as Paxlovid "will generally not be affected," at least as long as the current stockpile lasts. While the transition to traditional health care coverage will offer continued coverage for COVID-19 vaccines, out-of-pocket expenses for certain treatments will likely change. Medicaid telehealth flexibilities will not be affected. Americans can also anticipate paying for their coronavirus tests. "The requirement for private insurance companies to cover COVID-19 tests without cost sharing, both for OTC and laboratory tests, will end," the agency said.

The end of the public health emergency will also mean the end of mandatory reporting of test results by private labs, which the HHS said, makes it "challenging for us to use a metric such as percent positivity after the end of the public health emergency."

Xavier Becerra, Secretary of Health and Human Services, outlined the changes in a letter to governors. The Biden administration had previously promised to give state leaders 60 days' notice before ending the emergency order. "Rather than 60 days' notice, I am providing 90 days' notice before the COVID-19 PHE ends to give you and your communities ample time to transition," Becerra said. He added, "My team throughout the entire Department and I are eager to partner with you to ensure this process is as seamless as possible."

U.S. public health emergency renewed for the last time

Xavier Becerra, Secretary of Health and Human Services, on Thursday renewed the COVID-19 public health emergency order in the U.S. for what is expected to be the last time. After three years in effect, the two federal public health emergencies addressing COVID-19 will end on May 11, President Biden has announced. The state of emergency gave the federal government more flexibility with its resources to respond to COVID-19, and for most people, its removal will be felt primarily in the delivery and cost of pandemic health care.

USA Today: <u>Here's why Medicaid coverage and free COVID tests</u>, treatments will soon change Ken Alltucker

The Biden administration on Thursday formally notified states the COVID-19 public health emergency that provided generous federal payments to subsidize care and insurance coverage for millions will end May 11. About 15 million Americans who gained Medicaid health insurance during the COVID-19 pandemic are at risk of losing coverage later this year as generous federal subsidies end. Among the other changes: Private insurers will no longer be required to pay for home COVID tests, and vaccines and treatments will be free until early summer.

In a letter sent to governors on Thursday, HHS Secretary Xavier Becerra said COVID-19 cases plummeted 92% and deaths declined more than 80% since the omicron surge in January 2022. "We have come to this point in our fight against the virus because of our historic investments and efforts to mitigate its worst impacts," Becerra said in the letter.

The federal government provided billions in federal aid to states on the condition that they would not remove people from Medicaid until the public health emergency ends. The public health emergency ensured Americans didn't lose coverage during the pandemic, driving down the uninsured rate to 8%.

States will vary on when they resume eligibility checks. Consumers who lose Medicaid coverage can sign up for Affordable Care Act coverage during a special enrollment period.

Free COVID vaccines, treatments will continue through early summer

HHS officials said the federal government will continue to supply free COVID-19 vaccines and treatments such as Paxlovid until the federal supply runs out. So consumers will still be able to get a free COVID shot at a pharmacy through the spring and early summer.

However, the administration will shift costs to insurers and consumers later this summer or fall, officials said.

How coverage for COVID tests will change

Consumers who received free home or lab tests during the public health emergency will notice changes. Here's what people can expect:

- Consumers can still order free home tests through <u>COVIDtests.gov</u> but future access might change depending on test supplies and resources.
- Medicare will no longer pay for free home tests, but enrollees can get coverage for lab tests.
- **Medicaid** must cover testing through Sept. 30, 2024; state Medicaid programs will decide whether to continue coverage after that.
- **Private insurers** also will no longer be required to pay for eight home tests every month. Consumers should check with their insurer about continued access.
- **Those uninsured** might be able to get testing through pharmacies and community-based sites under a Centers for Disease Control and Prevention program.

Expect changes to testing and immunization data reporting

The federal government will no longer have the authority to require labs to report COVID-19 negative test results. That means the CDC might no longer be able to track the percentage of positive tests in a region – a key indicator of whether a virus is surging or a community is not testing enough. The CDC is asking states and local public health jurisdictions to sign voluntary agreements to continue sharing information on vaccine administration.

DEA seeks new rules on controlled substances

The pandemic allowed doctors and other practitioners registered with the Drug Enforcement Administration to prescribe controlled substances to patients remotely. This allowed people with opioid-use disorders to access treatments such as buprenorphine without visiting a medical office. DEA expects to write new rules to allow patients to continue to access such remote treatments.







Vox: "White House warns 21 million Americans at risk of losing Medicaid under GOP proposal"

Today, Vox reported on <u>new analysis</u> from the Department of Health and Human Services that shows how Speaker McCarthy's proposal would jeopardize health care for 21 million Americans who are enrolled in Medicaid.

The Speaker's bill would take health care away from millions of Americans by adding bureaucratic work reporting requirements for older Americans. When this MAGA policy was implemented in Arkansas, nearly 1 in 4 people subject to it lost their health care, including working people and people unable to work due to health conditions, with no evidence of increased employment.

Democrats are preparing to fight House Republicans' plan for Medicaid work requirements.

As many as 21 million Americans could be at risk of losing their Medicaid coverage under **the House GOP's work requirement proposal**, according to a new Biden administration analysis shared exclusively with Vox.

The projections are both a warning about the potential consequences of the strict reporting requirements Republicans are contemplating and ammunition for Democrats in the upcoming negotiations over **raising the federal debt limit**.

The House's work requirement proposal — dubbed a "community engagement" requirement in **the bill's text** — would mandate that many Medicaid recipients work, look for work, or participate in another kind of community service for at least 20 hours per week (though some conservatives want that number to be even higher).

According to **Punchbowl News**, these work requirements for social programs are, along with spending cuts and permitting reform, a top priority for the House GOP in talks over raising the federal debt ceiling.

Children under the age of 18, adults over 56, people on Medicaid with mental or physical disabilities, and parents of dependent children would largely be exempted. However, that exemption is not ironclad.

For one, states would have the ability to subject more people, such as parents, to the requirement, based on **the Georgetown Center for Children and Families's read of the bill's text**. Second, people with disabilities **could still be required to submit information to receive an exemption** — which raises the possibility that a snag in their paperwork could lead to them losing benefits.

In their new projections, the Biden administration estimated the number of Medicaid recipients who would be required to meet the work requirement or submit information to prove they should be exempted. Those are primarily people living in 40 states that have expanded Medicaid through the Affordable Care Act. Most of the expansion population is childless non-disabled adults, but some parents and some people with disabilities could also be subject to the reporting requirements depending on the state in which they live and their specific circumstances.

Several independent experts told me that they found the administration's figure to be "plausible." A recent Center on Budget and Policy Priorities (CBPP) analysis had **estimated** that at least 10 million people on Medicaid would face a "significant" risk of losing coverage under the proposal. (The CBPP estimate cautions that it is likely an undercount and did not include parents nor several of the most recent states to expand Medicaid in coming up with its projection.)

Not everyone subjected to a work requirement would lose coverage. The Congressional Budget Office **estimated** last year that requiring non-disabled, non-elderly childless adults to work in order to receive Medicaid benefits would lead to more than 2 million Americans losing coverage annually for failing to meet a work requirement. That would lead to a \$135 billion cut in Medicaid spending over 10 years — the stated goal of House Republicans.

The available evidence suggests many of those people would lose coverage not because they are failing to work

but because of administrative problems in verifying their eligibility. **A new KFF analysis** found that more than half of adults on Medicaid are already working full or part time, and most of the rest are either caregivers, have a disability, or are in school.

When Arkansas briefly instituted Medicaid work requirements during the Trump administration, before being stopped by a federal court order, **about 17,000 Medicaid beneficiaries** lost their health coverage with **no discernible impact on employment**. Experts expect the same story would play out if work requirements were implemented nationally.

"The savings here would mostly come from the paperwork burden that a work requirement adds to Medicaid, with people falling through the cracks of the verification process," Larry Levitt, executive vice president at the

nonprofit think tank KFF, told me.

So why are Republicans still pursuing Medicaid work requirements? Part of it is a genuine conservative belief that income-based eligibility discourages people from working, despite the evidence that most adult Medicaid recipients are either working or should be eligible for an exemption. Conservatives in the House want an ideological win in the debt-limit deal and work requirements would give them one they have long sought.

They also have limited options to find significant spending cuts. By taking Medicare and Social Security **off the table** — and presuming Republicans don't want to cut spending on the military and veterans — **roughly half of the federal budget** is off-limits. Medicaid is the biggest federal program they are comfortable proposing cuts for, in part because their base still (**narrowly**) views it as a welfare program.

Republicans also think they can sell Medicaid work requirements politically. Punchbowl News **reported** that internal House GOP polling showed that work requirements were popular among voters in the competitive districts that will determine future House control.

But public polling suggests it's a little more complicated than that. **As I wrote in 2018**, Americans are of two minds about work requirements. When asked if they support requiring work in order to receive certain government benefits, the public will generally say yes. But when those policies are framed differently, and particularly when they are portrayed as cuts, their popularity drops.

Most Americans **say** they approve of the Medicaid program, which has played a critical safety net role in the Great Recession and the Covid-19 pandemic, and has also expanded its rolls significantly since the ACA's passage. Most also **say** they oppose spending cuts to the program.

The Biden administration's new projections will help Democrats make their case if House Republicans continue to insist on Medicaid work requirements as part of any future debt-limit deal — and it is a signal that they are prepared to fight hard over one of the GOP's top priorities.
