Perrie- thanks it was a good weekend. Glad you were able to get some more information from Healthy schools. Yeah, I agree we need to get more of a handle on the reimbursement for SBS. The biggest barrier is SBS is not a specific 1905(a) service and therefore can be picked up under any of the possible services in 1905(a), and then for kids under EPSDT as well. Of course you should clarify to health schools that we are not requiring CPEs as a funding source- not to be confused with a complete methodology. Regardless of the funding source (taxes, appropriations, IGTs, or CPEs) the chosen methodology must be comprehensive.

WY was clear they were just starting IEP services only in their recent SPA. UT recently finished a change in methodology, and I hear they regret not adding free care- as we suggested.

My thoughts:

2. I would probably say something like one of these:  $\hat{a} \in \hat{a} \in \hat{c} \hat{a} \in \hat{c}$  these states have expanded *Medicaid* school-based health care services beyond Individualized Education Plans for disabled students. These states are taking advantage of the 2014 Medicaid SMDL that expanded services beyond those for disabled students with IEPs. $\hat{a} \in \mathbb{Z}$ 

I think it is a little disingenuous for us to present all of the states as completely open to free care since some are only open to nursing services (GA, LA) for instance- but nuisance is hard to get across in a short press release. And I think it is Healthy schoolsâ€<sup>™</sup> job as advocates to highlight and celebrate all the expansion states. Also, I probably sound like a broken record but I have not seen a FL SPA that opens up a viable reimbursement methodology for SBS- FL has a 1997 SPA and then a reimbursement SPA, but nothing I have seen other than that (the 1997 SPA was reimbursing with cost using rates- which is not allowed under federal cost principles). I did just discover a companion letter was written to them in 2020 asking them to come into compliance with current CMS SBS policy, but I am not sure where that stands- checking now.

I love the last line!- CMS celebrates and supports all states in expanding school health care services to more children with Medicaid.

See response below from Lena at Health Schools on how they count free care. I highlighted in yellow what I thought of as the key point about how Healthy Schools accounts for the 5 additional states.

Two questions for you:

- I do want to send Lena a response but wanted to check with you on your thoughts and if you have additional questions (I can also loop you into the thread). One thing I do want to emphasize for Lena is we are not suggesting that CMCS require CPE as a condition for billing outside the IEP. I think it is just hard for us to track/confirm/account for what states are doing if they donâ€<sup>™</sup>t submit a SPA.
- 2. Given all this, for the press release, I wonder if we edit to something like this â€" thoughts?: New Mexico/Illinois joins 12 other states that have already expanded school-based health care services through Medicaid "free careâ€2 by submitting a SPA to CMS. Other states that have submitted a free care SPA to CMS include Arizona, California, Colorado, Connecticut, Florida, Georgia, Kentucky, Louisiana, Massachusetts, Michigan, Nevada, and North Carolina. Heyo! Great question! Here are a few early morning thoughts.

To us, the question to solve is "how can a school bill for services outside of an IEP". We count--and celebrate--<u>any</u> expansion outside of an IEP. Our recommended best practice is to cover all medically necessary services for all Medicaid enrolled kids (e.g. CO, MI) but we will count a partial expansion as well.

For those states who have partial expansion, we acknowledge it and encourage states to go further. Once the camel's nose is under the tent, it's easier to understand and expand more. For example, and a slight correction to your list above, Louisiana initially expanded nursing services only and then went back and got a <u>second SPA</u> for more services. Georgia is now doing a similar thing and is working towards a more expansive SPA.

We are agnostic about financing options and focus on <u>expansion</u> outside the IEP. The 2014 free care reversal letter doesn't mention methodology, nor does the August 2020 letter section on free care. We interpret this to mean that the issues of expansion and financing aren't linked. There is the expansion outside the IEP (free care) and then, separately, how a state finances school Medicaid. We are in favor of whatever methodology works for a state to expand coverage.

If this is just about <u>defining</u> "free care" states and naming things, I understand the impulse. That said, I would be deeply concerned about any policy that would require CPE as a condition for billing outside the IEP. It would be a huge shift for the states who are using a different methodology now and it would be a big shift in how things are talked about. It would absolutely chill state response and creativity if they think they have to change methodology to expand. HSC would have to think very carefully before it could support that shift.

The 5 states you have listed, plus ND, did not ever codify the "IEPs only" language in their state plan and so, did not need a SPA to reverse it. They were able to expand without a SPA. They do allow billing for services outside the IEP and they have that documented in *guidance*. I have the underlying guidance documents linked in our <u>free care tracker</u>.

We do NOT count WA (which pisses them off) but they don't allow billing for non-IEP services but they encourage MCOs to cover non-IEP services in a school setting. This, to us, is not the same thing as coverage outside an IEP.

We do NOT count WY (which pisses <u>me</u> off) because while their SPA reads like it has expanded outside the IEP, their guidance documents clearly indicate that they will only reimburse for IEP services.

In sum, our list defines the states as those who have expanded outside of the IEP and we count partial expansions. Anything that gets more money into a school to support kids. As a parallel, we celebrate postpartum expansion in MS--but the full Medicaid expansion would definitely be better.

Hope this helps. Jessie and I are happy to talk more if helpful.

I also have a separate question for you, and of course loop in whoever you think is best here! The question is, how does Healthy Schools count free care states?

We are doing an updated count to include in future press releases, and are realizing that we are getting a slightly different number than Healthy Schools. We count 12 states with free care and Healthy Schools counts 17, soon to be 18 with SD. Breakdown below. And of course, it gets complicated once you dive in.

The definition for how we get to 12 states is that each of those states have SPAs related to payment for school-based services, more specifically to a CPE payment methodology. And these SPAs are not necessarily always for *all* Medicaid services – for example, GA and LA only provide for nursing services. We have also seen incoming SPAs that only expand to a subset of kids beyond those with IEPs (e.g., only to kids with 504). Other states may provide health services to children with Medicaid in schools, but are using a different methodology or vehicle that does not require a SPA (e.g., contracted services, paying normal FFS rates for SBS, etc., but not having a SPA with a cost reconciliation reimbursement methodology).

Let me know your thoughts. Our goal in getting an accurate or consistent count is as a way to encourage more states to pick it up. Similar to what we have done with the postpartum extension, we want to able to celebrate each state and announce what # state they are to take up the option.

## Hi Rory.

I have briefly reviewed these protocols and followed up with DECD staff. My understanding is that they were all reviewed by FMG and then approved for the previous period of performance. For this current period of performance **there are very few edits** from the state provided in redline, and the most extensive edits are the addition of an equity component to the Attachment L valuation scheme. I understand from staff that Mark Wang and Brian Burdullis conducted the previous review that led to our approval, and that a different state financial lead is now responsible for CA.

That said, the relevant STCs are as follows: STC 69-83 focus on the Global Payment Program, and to understand the payment structures, STCs 74, 76-78 and 83 outline the specific protocols we are requesting for review. While there are only a few edits from the state, we think FMG review for accuracy and completeness relative to the STCs is needed in so much as they outline accounting processes and procedures for reporting GPP, and a methodology that encompasses payment structure. More specifically,

Attachment K- need review of the reporting dates, are they appropriate for the state to submit

Attachment F- are these accounting processes and procedures appropriate and complete

Attachment L- any feedback on the state's updated the point values

Attachment Q- review the GPP percentages

I provide below information about these CA protocols and an email string between SDG and FMG staff trying to establish TA. We are still in pursuit of that TA. Can you please help us determine who to work with and how best to move forward in the TA we need?

Also, perhaps you already know this, but DECD met with the CA financial lead and FMG team in May to get a better understanding of the different roles in FMG. Following FMG restructuring, SDG sometimes finds it confusing to determine who should be reviewing financial policy (FPO), financial reporting (FMR), protocols, etc. That is to say, sometimes we are not sure who to contact and how to get started with FMG engagement.

Please let me know if you have questions or would like to discuss. Thank you for your ongoing collaboration. Terese

California protocols -- SDG needs assistance from FMG to review the CalAIM Global Payment Program (GPP) Funding and Mechanics Protocol and CalAIM GPP Fund Valuation Methodology Protocol. Both were submitted in March 2022.

To understand the context of the protocols, the GPP protocols are a combination of: (1) a portion of the state's annual Disproportionate Share Hospital (DSH) allotment and (2) its Uncompensated Care (UC) Pool funding for value-based payments to participating California Public Health Care Systems (PCHS) providing care for California's uninsured. These payments support efforts to provide services for the uninsured, promote the delivery of higher-value care, and incentivize more appropriate and cost-effective care. The state updated the Funding and Mechanics Protocol and the Valuation Methodology Protocol for CMS approval by adding new GPP services that may facilitate addressing health disparities for the uninsured population, as well as align GPP service offerings with those available to Medicaid beneficiaries.

The state will need these protocols reviewed and approved for the new funding structure in order to make the value-based payments to participating California Public Health Care Systems (PCHS) providing care for California's uninsured.

On September 7 DSRD had a brainstorming call with FMG. Below are the attendees from the call, although not all of the listed attendees attended. DSRD remembers Andrew Badaracco and Davida Kimble were the most helpful on the call. On the call SDG and FMG discussed additional options to support the state and rural hospitals. FMG suggested having the state use state only funds to cover the overpayments from DY 9 and seeking an amendment for expenditure authority to make the state whole. These options were later deleted from the paper after discussions at Prep. SDG and FMG also discussed options of recoupment through DY 11 and interim payments. FMG raised questions about claiming during the meeting. DSRD did not discuss with FMG the possibility of not recouping in DY 9 at all, because our focus at that time was to provide options that were available to the state for recoupment.

On the claiming adjustment question, DSRD reached out to Kevin Slaven, the Financial Lead for Kansas, on Friday 9/30 and then again on Monday 10/3.

Hi Rory, Amber and Jeremy. We plan to bring this paper to SDG clearance tomorrow. We think some questions might come up that FMG would need to weigh in on, so wanted to give you a heads up. Also, please see question below in yellow highlight. We'd like to know the answer to this question before going into the SDG clearance mtg.

I understand that DSRD met w FMG to talk through options for responding to the state not having followed the approved protocol for distributing funds to hospitals, and now it looks like rural hospitals were significantly overpaid in DY9, and the OIG is paying attention to this issue. So the question this paper raises is whether and how to direct the state on correcting payments already made in DY 9. We thought only three of the five options FMG and DSRD discussed were options we'd likely take, so we only presented those three.

Is it possible to give us an answer on the question raised in the comments on this paper...does the two year claiming adjustment limitation apply in this situation where we think the state has improperly paid out the UC funds to hospital in DY9, not yet made paid out any DY10 funds, and likely would need the better part of two years to work w rural hospitals to adjust their S-10 data so that any correction would be based on reliable data?

Hi Amber and others,

Thank you for connecting on Medicaid data! Now that we know who to reach out to, we thought weâ $\in$ <sup>M</sup>d send some more specific data to guide our questions and conversation.

We are currently attempting to estimate the fiscal relief states will have received through the FFCRA 6.2PP FMAP bump through March 2023 and potentially, through the end of December 2023. This is an update of a <u>piece</u> we put out last year, using some updated methodology and data sources. At a high level, our fiscal relief calculations are based on total Medicaid spending data (excluding group VIII expenditures), and we are deciding whether to base our estimates on the quarterly MBES group VIII expenditure reports or the annual FMR reports. We are also comparing our model estimates to the fiscal relief under FFCRA section 6008 reported through MBES <u>here</u>.

The attached excel file includes two tabs: the first one shows the differences between the MBES and FMR total spending amounts for FY 2021 and the second shows the estimated fiscal relief for FY 2020 and FY 2021 from the MBES. Some specific questions are listed below.

- 1. Do you know why the FMR and quarterly MBES estimates for total spending are so different? The attached file shows those differences, which are particularly notable in CA and WA in FY 2021.
  - a. Our understanding is that the data sources differ because the FMR reports include collections and overpayment while the MBES does not and because the MBES quarterly estimates include prior period adjustment claims. Do you know whether the differences are primarily attributable to one of those factors or the other?
  - b. When comparing total Medicaid spending growth from FY20 to FY21 for all 50 states and DC, the MBES total grows 5% while the FMR report total grows by 10%. When thinking about Medicaid growth rates, what do you think is the most likely scenario?
  - c. Given all of these factors, would you recommend using one of those sources over the other for our analysis of fiscal relief during the continuous enrollment period?
- 2. We are comparing our estimates of fiscal relief to those posted <u>here</u> and have noticed some discrepancies that we are having trouble explaining.
  - a. Are there timing issues or other situations such that the timing of when the payments show up in the MBES may be different from when the payments were made or the states incurred the costs?
  - b. For 3 states, fiscal relief was lower in 2021 than in 2020, which was surprising to us as the FMAP bump only applied to three quarters of 2020. Do you have any thoughts as to why that might be the case?
  - c. We noticed some big differences in the total computable all medical assistance expenditures depending on whether we pull spending totals from the group VIII expenditure reports or the <u>FFCRA increased FMAP expenditure</u> <u>report</u>. Do you know why the total spending would be different across those two reports?

i. For example,  $CA\widehat{a} \in \mathbb{T}^{m}$ s total spending for the quarter ending 3/2022 was reported as \$31,926,997,852 in the increased FMAP report, but \$21,939,995,197 in the group VIII expenditure report.

I elevated this to our group leadership and here are our concerns.

 Our preference is for the State to remove the "pre-arrangedâ€□ language as appropriate. In response to Q16 in the Round 1 comments indicated the following:

Please affirm that no payment under this section is dependent on any agreement or arrangement for providers or related entities to donate money or services to a governmental entity.

STATE RESPONSE: The state affirms that that no payment under this section is dependent on any agreement or arrangement for providers or related entities to donate money or services to a governmental entity.

Itâ€<sup>™</sup>s not clear how this affirmation aligns with the stateâ€<sup>™</sup>s response aligns with the stateâ€<sup>™</sup>s response to question #5 in the Rd. 2 questions in which we discuss the "pre-arrangedâ€□ language. It may be necessary for the state to assess and affirm that the language in the LOA and the affirmation they have made to CMS in Q5 does not permit the providers to engage in any agreements, written or otherwise, that would require any non-governmental providers or related entities to donate money or services to a governmental entity in exchange for the payment under the proposed SDP.

2. The State's response regarding Lee Health is not complete. The State indicated that Lee Health has neither State appropriated funds or access to tax revenue, so we are asking for the source of the funds for Lee Health. In the past, we have certainly accepted that state's can designate providers as units of State or local government, but their affirmation that Lee Health is public and has access to funding allowed under 433.51 does not align with the information the State provided in their excel file. Further, the State affirmed that much of the information we copied/pasted directly from their own excel file provided with the pre-print is not accurate, but has yet to be corrected.

Generally speaking, if we received these types of responses as part of a SPA review, FMG would ask additional questions, seek counsel from OGC, and possibly pursue disapproval if adequate information is not provided. I know this feels like a small thing, but we asked similar questions in the other FL SDP regarding the State Teaching Hospitals and would like to avoid accepting incomplete answers and relying upon conditional approval.

At this point, I defer to you all as to how you'd like to proceed and your question about whether or not we move forward with conditional approval.

Here's what I see:

- 1. The state provided inaccurate information in their IGT write up, which likely needs to be corrected. Does DMCP expect the state to correct the submitted records for their IGTs?
- Lee Health â€<sup>w</sup> The state did not answer the question we asked about Lee Health and the source of funds. They just said "Lee Health is a public provider and eligible to provide non-federal share under 433.51.â€□ It's not abundantly clear what those sources are, but perhaps the quoted approval letter language would suffice there.
- 3. Pre-Arranged language â€" This was the one that seems oddest to me. The agreement includes language that would permit providers to enter into agreements after approval of the SDPs that might permit the providers to pool their IGT funds or recycle funding. Again, this might fall into the quoted language you cited, but I want to get concurrence from our OGD.

STATE RESPONSE: None of the above includes George Weems Hospital, which is a public hospital in Region 2. However, George Weems Hospital, and in fact all of the public hospitals in Region 2, will have a zero percent rate increase in Year 3 and will not be transferring any funds.

The chart above is incorrect with respect to the North Broward Hospital District and the Public Health Trust of Miami-Dade County. Both the North Broward Hospital District and the Public Health Trust of Miami-Dade County have the authority to assess (and do assess) ad valorem taxes. Thus, the response for whether the Transferring Entity has General Taxing Authority should be "Yes.â€□

The entity that is transferring funds for Ed Fraser Memorial Hospital is Baker County Hospital Authority, which is a hospital taxing district with general taxing authority. Baker County Hospital Authority should have been listed rather than Ed Fraser Memorial Hospital.

Lee Health is a public hospital and a special district created under Florida law but does not have general taxing authority. Lee Health's transfer is derived from public funds permitted to be transferred pursuant to 42 C.F.R. § 433.51.

Does DMCP expect the state to update their IGT documents (yellow)? To me, if the files sent to us are incorrect, they should be corrected. With regard to Lee Health (green), that response doesnâ $\in$ <sup>mt</sup> really answer our question of  $\hat{a}\in \mathbb{C}$ What is the source of the non-federal share if the provide does not have access to state tax revenue or state appropriations? $\hat{a}\in\Box$  Just because a provider is considered  $\hat{a}\in\mathbb{C}$ public $\hat{a}\in\Box$  it doesn $\hat{a}\in\mathbb{T}$ t always mean that they can provide an IGT.

Hi Lovie –

 In response to the stateâ€<sup>™</sup>s question #18, the state asked us to identify the hospitals that do not have taxing authority and do not have access to appropriations. The state identified Jackson Memorial and George Weems Hospital, and noted their sources of fundings. Upon review of the submitted data, the stateâ€<sup>™</sup>s original list from the original Att. 35 Spreadsheet included the following four hospitals/entities:

It seems that the state has provided sources for the Public Health Trust of Miami-Dade County, which operates Jackson Memorial, as Ad Valorem taxes. It's not clear which of the above includes George Weems Hospital, though. Please advise where the funding for the above four entities comes from if they do not have access to state appropriated funds, or general taxing authority.

2. In reviewing the IGT agreement document provided by the state, I have the following requests:

In Section A.6, the language says:

"IGT Provider confirms that there are no <u>pre-arranged</u> agreements (contractual or otherwise) between the respective counties, taxing districts, and/or the providers to re-direct any portion of these aforementioned supplemental payments in order to satisfy non-Medicaid, non-uninsured, and non-underinsured activities.â€□

We request the removal of the term  $\hat{a} \in \mathbb{C}$  pre-arranged  $\hat{a} \in \mathbb{C}$  as this implies that there may be agreements, so long as the agreements are reached after the supplemental payment program is implemented. We believe this interpretation is supported by the language in A.7 below, which implies that the transferring IGT providers are engaging in agreements with non-IGTing providers regarding the payments and the non-federal share. Please advise.

"IGT Provider agrees the following provision shall be included in any agreements between IGT Provider and local providers where IGT funding is provided pursuant to this LOA. 



I elevated this to our group leadership and here are our concerns.

 Our preference is for the State to remove the "pre-arrangedâ€□ language as appropriate. In response to Q16 in the Round 1 comments indicated the following:

Please affirm that no payment under this section is dependent on any agreement or arrangement for providers or related entities to donate money or services to a governmental entity.

STATE RESPONSE: The state affirms that that no payment under this section is dependent on any agreement or arrangement for providers or related entities to donate money or services to a governmental entity.

Itâ€<sup>™</sup>s not clear how this affirmation aligns with the stateâ€<sup>™</sup>s response aligns with the stateâ€<sup>™</sup>s response to question #5 in the Rd. 2 questions in which we discuss the "pre-arrangedâ€□ language. It may be necessary for the state to assess and affirm that the language in the LOA and the affirmation they have made to CMS in Q5 does not permit the providers to engage in any agreements, written or otherwise, that would require any non-governmental providers or related entities to donate money or services to a governmental entity in exchange for the payment under the proposed SDP.

2. The Stateâ€<sup>™</sup>s response regarding Lee Health is not complete. The State indicated that Lee Health has neither State appropriated funds or access to tax revenue, so we are asking for the source of the funds for Lee Health. In the past, we have certainly accepted that stateâ€<sup>™</sup>s can designate providers as units of State or local government, but their affirmation that Lee Health is public and has access to funding allowed under 433.51 does not align with the information the State provided in their excel file. Further, the State affirmed that much of the information we copied/pasted directly from their own excel file provided with the pre-print is not accurate, but has yet to be corrected.

Generally speaking, if we received these types of responses as part of a SPA review, FMG would ask additional questions, seek counsel from OGC, and possibly pursue disapproval if adequate information is not provided. I know this feels like a small thing, but we asked similar questions in the other FL SDP regarding the State Teaching Hospitals and would like to avoid accepting incomplete answers and relying upon conditional approval.

At this point, I defer to you all as to how you'd like to proceed and your question about whether or not we move forward with conditional approval.

Hi Laura –

Here's what I see:

- 1. The state provided inaccurate information in their IGT write up, which likely needs to be corrected. Does DMCP expect the state to correct the submitted records for their IGTs?
- Lee Health â€" The state did not answer the question we asked about Lee Health and the source of funds. They just said "Lee Health is a public provider and eligible to provide non-federal share under 433.51.â€□ It's not abundantly clear what those sources are, but perhaps the quoted approval letter language would suffice there.
- 3. Pre-Arranged language â€" This was the one that seems oddest to me. The agreement includes language that would permit providers to enter into agreements after approval of the SDPs that might permit the providers to pool their IGT funds or recycle funding. Again, this might fall into the quoted language you cited, but I want to get concurrence from our OGD.

Essentially, the state does not provide the source of the non-federal share for at least one of the facilities and questions the accuracy of the chart that they provided. For example  $\hat{a} \in \mathbb{N}$ 

STATE RESPONSE: None of the above includes George Weems Hospital, which is a public hospital in Region 2. However, George Weems Hospital, and in fact all of the public hospitals in Region 2, will have a zero percent rate increase in Year 3 and will not be transferring any funds.

The chart above is incorrect with respect to the North Broward Hospital District and the Public Health Trust of Miami-Dade County. Both the North Broward Hospital District and the Public Health Trust of Miami-Dade County have the authority to assess (and do assess) ad valorem taxes. Thus, the response for whether the Transferring Entity has General Taxing Authority should be "Yes.â€□

The entity that is transferring funds for Ed Fraser Memorial Hospital is Baker County Hospital Authority, which is a hospital taxing district with general taxing authority. Baker County Hospital Authority should have been listed rather than Ed Fraser Memorial Hospital.

Lee Health is a public hospital and a special district created under Florida law but does not have general taxing authority. Lee Health's transfer is derived from public funds permitted to be transferred pursuant to 42 C.F.R. § 433.51.

Does DMCP expect the state to update their IGT documents (yellow)? To me, if the files sent to us are incorrect, they should be corrected. With regard to Lee Health (green), that response doesnâ $\in$ <sup>TM</sup>t really answer our question of â $\in$ ceWhat is the source of the non-federal share if the provide does not have access to state tax revenue or state appropriations?â $\in$  Just because a provider is considered â $\in$ cepublicâ $\in$  it doesnâ $\in$ <sup>TM</sup>t always mean that they can provide an IGT.

Iâ€<sup>™</sup>d also like to elevate the "pre-arrangedâ€□ language that the state has indicated in their response that they cannot address at this time. Perhaps itâ€<sup>™</sup>s something for which we can say: "There is risk associated with the retention of this language. IGT funds found to be derived from non-bona fide provider related donations could be subject to future financial findings.â€□

2. In reviewing the IGT agreement document provided by the state, I have the following requests:

In Section A.6, the language says:

 $\hat{a} \in \mathbb{C}$  Brovider confirms that there are no <u>pre-arranged</u> agreements (contractual or otherwise) between the respective counties, taxing districts, and/or the providers to re-direct any portion of these aforementioned supplemental payments in order to satisfy non-Medicaid, non-uninsured, and non-underinsured activities. $\hat{a} \in \Box$ 

We request the removal of the term "pre-arrangedâ€□ as this implies that there may be agreements, so long as the agreements are reached after the supplemental payment program is implemented. We believe this interpretation is supported by the language in A.7 below, which implies that the transferring IGT providers are engaging in agreements with non-IGTing providers regarding the payments and the non-federal share. Please advise.

"IGT Provider agrees the following provision shall be included in any agreements between IGT Provider and local providers where IGT funding is provided pursuant to this LOA. Funding provided in this agreement shall be prioritized so that designated IGT funding shall first be used to fund the Medicaid program and used secondarily for other purposes.â€□

## **Background:**

Hi Amber and others,

Thank you for connecting on Medicaid data! Now that we know who to reach out to, we thought weâ $\in$ <sup>M</sup>d send some more specific data to guide our questions and conversation.

We are currently attempting to estimate the fiscal relief states will have received through the FFCRA 6.2PP FMAP bump through March 2023 and potentially, through the end of December 2023. This is an update of a <u>piece</u> we put out last year, using some updated methodology and data sources. At a high level, our fiscal relief calculations are based on total Medicaid spending data (excluding group VIII expenditures), and we are deciding whether to base our estimates on the quarterly MBES group VIII expenditure reports or the annual FMR reports. We are also comparing our model estimates to the fiscal relief under FFCRA section 6008 reported through MBES <u>here</u>.

The attached excel file includes two tabs: the first one shows the differences between the MBES and FMR total spending amounts for FY 2021 and the second shows the estimated

fiscal relief for FY 2020 and FY 2021 from the MBES. Some specific questions are listed below.

- 1. Do you know why the FMR and quarterly MBES estimates for total spending are so different? The attached file shows those differences, which are particularly notable in CA and WA in FY 2021.
  - a. Our understanding is that the data sources differ because the FMR reports include collections and overpayment while the MBES does not and because the MBES quarterly estimates include prior period adjustment claims. Do you know whether the differences are primarily attributable to one of those factors or the other?
  - b. When comparing total Medicaid spending growth from FY20 to FY21 for all 50 states and DC, the MBES total grows 5% while the FMR report total grows by 10%. When thinking about Medicaid growth rates, what do you think is the most likely scenario?
  - c. Given all of these factors, would you recommend using one of those sources over the other for our analysis of fiscal relief during the continuous enrollment period?
- 2. We are comparing our estimates of fiscal relief to those posted <u>here</u> and have noticed some discrepancies that we are having trouble explaining.
  - a. Are there timing issues or other situations such that the timing of when the payments show up in the MBES may be different from when the payments were made or the states incurred the costs?
  - b. For 3 states, fiscal relief was lower in 2021 than in 2020, which was surprising to us as the FMAP bump only applied to three quarters of 2020. Do you have any thoughts as to why that might be the case?
  - c. We noticed some big differences in the total computable all medical assistance expenditures depending on whether we pull spending totals from the group VIII expenditure reports or the FFCRA increased FMAP expenditure report. Do you know why the total spending would be different across those two reports?

i. For example,  $CA\hat{a} \in \mathbb{T}^{M}$ s total spending for the quarter ending 3/2022 was reported as \$31,926,997,852 in the increased FMAP report, but \$21,939,995,197 in the group VIII expenditure report.
